### YOU DON'T HAYE TO PAY TO FILE YOUR TAXES !!!

You might have seen them around your neighborhood. They pop up overnight, out of nowhere. Suddenly one morning there's a Jackson Hewitt or an H & R Block on your corner! What are these places?

They are **tax preparers**, and they will file your taxes for you, often **for a big fee**. What they don't tell you is that you can file your taxes on your own, and if you have a bank account you can get your refund straight from the IRS within one to two weeks—without paying the

actually refund is The LOAN. which will take a bite out of your refund, in the form of fees and interest on the loan. These loans are called "refund anticipation loans," or RALs, because it is a loan on the amount of money you anticipate getting Waiting even a few days to back. receive your refund from the IRS will save you a lot of money! The annual percentage rate on these loans can be really high, as much as **700 percent!** 

These high cost tax preparers sometimes say that using their services is the only way to get your refund fast. This is not true! If you get an instant refund from a tax preparer, you will get your return in 2-3 days, but you will pay high fees. Using one of the many free tax prep sites around the city, you can get your return in 8-10 days (if you file electronically).

### WHY PAY TO GET YOUR OWN MONEY?

Big banks are involved in making tax refund loans. For example, Household International is behind H & R Block's tax operations. In 2001, H & R Block made \$8.4 billion in tax refund loans, to 6.4 million people. Most people who use got these loans have incomes under \$20,000.

People with low incomes can least afford to pay high fees to get back their tax refunds - and yet they are charged super-high fees to get back their money.

You don't have to pay to get your taxes.
